Objectives and activities

We are Dundee Pride and our mission is to take a positive stance against discrimination and violence toward the lesbian, gay, bisexual, trans, plus (LGBT+) community and to progress LGBT+ equality, awareness and inclusion within Dundee and the region. Our vision is to create a city and region where LGBT+ people have a strong sense of community, are a visible social group and can celebrate their history, activism and sexual and gender diversity.

Our aims are to advance citizenship and community development within the LGBT+ community in Dundee and to promote equality and diversity

Each year we host Dundee Pride, a major celebration and festival for

LGBT+ people and their allies. We also hold at least one other event each year to advance our charitable aims.

Pride events continue to be needed to combat homophobia, transphobia and biphobia. We see this



need with the recent release of hate crime statistics for the 2019-20 financial year. Here we can see a snapshot of equality, diversity and inclusion in Scotland through the lens of the criminal justice system. Reported hate crimes increased this year compared to the previous years. Hate crimes based on race remain the highest incidence and increased by 4%. Crimes based on sexual orientation are the 2nd highest category and they increased by 24% compared to the previous year. The statistics do not include gender-based crimes and we know that most hate crimes do not get reported. Clearly there is still much to be concerned about for people with one or more protected characteristic especially in Dundee. Dundee saw a 15% increase in reported hate crimes.

Looking specifically at the rate of reported crimes based on sexual orientation, Dundee had an increase of 71%, from 49 reported cased the previous year to 69 cases in 2019/20. That's more than double from the year before. So though in many way social norms are changing and LGBTQ+ people have legal protections and are more accepted in society, there is still much work to be done.

Given political events around the globe the statistics remind us that the advances made in equality for women, BAME people, disabled people, religious minorities and the LGBT communities are precarious and could be quickly reversed. The killing of George Floyd and other people of colour around the world give clear evidence that minority groups are far from equal. The Pride movement continues to be needed today. We at Dundee Pride stand in solidarity with all of our sisters, brothers, and siblings from all backgrounds to push back against hate and work for equality and equity.

Structure, governance and management

Type of governing document

Dundee Pride is a Scottish Charitable Incorporated Organisation and has a Constitution to govern our activities. We are set up as a single Tier SCIO.

Trustee recruitment and appointment

We began a recruitment process at the tail end of the 2018/19 financial year to replace two trustees who left the Board of Trustees in December 2018. We identified needing a range of skills including project management, fundraising, legal. We advertised using social media channels and the appointment of Linda Stewart was made. We lost 2 trustees in October/November and again recruited through social media and networking. We appointed Jane Helppleston and Alex Muir at the end of the fiscal year. Our appointment process included asking for a CV and statement. The statement must cover the skills they will bring to the charity, the reasons for their interest and how they will contribute to the charity. An informal meeting is held with at least one trustee. The applicant is then invited to a trustee meeting to observe and ask questions. The trustees then vote on the appointment.

Staffing

The charity is run by volunteers and there are no staff members.

Achievements and performance


On the 22nd of September 2019 we held our second Dundee Pride event. The event kicked off with 4,000 people participating in a march through the city centre and then entering the festival area in Slessor Gardens. Over the course of the day we had 14,478 entries into the Pride Festival ground in Slessor. The event received considerable media coverage and was an inclusive and positive event.



Using the event IMPACTS economic impact assessment methodology, Dundee Pride brought £350,351 in the local Dundee economy. As such, Dundee Pride had a large and positive economic impact in the region. The assessment also suggests that the event supported 5 jobs in the local economy. Over 94% of the respondents rated the overall event as either Very Good or Good and 98% said they would attend Pride again. As such, we are building a brand that will likely keep people coming back for more events in the future, thereby increasing our economic impact over time.




Figure 1: The events impact on individuals






Figure 2: Impact on impression of Dundee

Though economic impacts are important, this is not the primary aim of the event. Instead the event is designed to further our charitable aims including increasing the visibility of LGBTQ+ people in Dundee, promoting equality and diversity and building community. The event did indeed further these aims. For example, 65% of the participants we surveyed (n=374) during and immediately after the event said that the event helped them feel proud of who they were and 41% said Dundee Pride fostered their sense of place and pride in the City of Dundee (see figure 1). Additionally, just under 90% of respondents reported that the event positively affected their impression of Dundee as a city (see figure 2).

Approximately 1/3 of the respondents identified as straight. This suggests that the event helped develop LBTQ+ allies in the wider community. Allyship is known to be a key factor in supporting LGBTQ+ people. Just under 1/3 of the respondents said they attended with children under the age of 16, which promotes inclusion and acceptance within the next generation of Dundee citizens.

Survey comments from participants provided additional evidence that we were meeting our aim to advance citizenship and community development within the LGBT+ community in Dundee and to promote equality and diversity. The following quotes are illustrative of the many comments that respondents made on the survey:

the overall experience of being there and being in a safe environment. The people made me feel so welcomed. I was able to be myself and I felt truly at ease. The entertainment and also the educational purpose of it also.

Hopefully publicity & funding wise this can be kept going, it was such an amazing and important event - we learnt a lot about the scene locally, made new friends, and discovered a whole scene of which we were previously unaware. It was a huge relief as we live quite isolated otherwise, and now we have new friends and are looking forward to visiting Dundee on the bus again to go to venues like BingoWigs, Churches, Klozet, Pout and all these other places - and also to shop for all the amazing local clothing on offer at Slessor!! - which we didn't know of at all before. We had

been quite sad, and now we are not - and that is thanks to you. X


In addition to this major event in the City Centre and Slessor Gardens, in 2019 we also held a weeklong cultural festival the week leading up to Pride. Events included make up & skin care tutorials for the LGBTQ+ community at Debenhams, a series of online articles from V&A Dundee, Queer Question Time, Dance Workshops with Shaper Caper, Drag Show and Bingo at the nightclub Church, film screenings and discussions at Dundee Contemporary Arts and Dundee University Students Assocation (DUSA), Pride Proms with LGBT Youth Scotland and Dundee City Community Learning and Development, Karaoke competitions at Arctic Bar, Church, Klozet and Salty Dog/Pillars, Drag Queen Story Time at Waterstones Book Store, Pride Talks at the Vine, art exhibits at The Queer Dot's space, The LGBTI+ Elders Social Dance Club in conjunction with the National Theatre of Scotland,



lecture at Abertay University on gay gaming, free yoga workshops with Heart Space yoga & Bodyworks, a film sing-a-long with the DCA, an Eden Mill gin tasting evening at the APEX hotel, a drag brunch and workshop with the McManus, and a design workshop at the V&A.

Finally we held a series of monthly blethers across the year to involve people in planning, to engage in citizenship building, and improve social capital amongst the Dundee LGBT community.
